Format:

Friday will showcase the new 2018 eventing dressage tests. Mark Weissbecker, an “R” judge and member of the committee responsible for creating the new dressage tests, will explain each test focusing on what the sequencing demonstrates and what the judge is looking for with each movement. This will offer riders great insight into the judge's perspective.

On Saturday, John Zopatti, a USDF Gold Medalist, will coach riders in their warm up with strategies to better prepare them for their test. Riders will then ride the test of their choice for Mark. They will receive feedback and critique on their execution of the test.

Riders can sign up to be an exhibition rider Friday and participate on Saturday for the Fix-A-Test. Limited space for exhibition riders on Friday so sign up early!

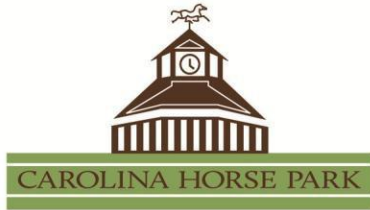
