

Anyone planning to attend this competition must read all the bullet points below before arriving at The Carolina Horse Park. Also please familiarize yourself with the USEF Covid-19 Action Plan (see link below)

- WHES Participants (competitors, groom, coach, parent), Staff, Officials and Volunteers are required to read the USEF Covid-19 Action Plan. [CLICK HERE](#)
- **All competitors must enter and exit the Park**, through the Trailer Entrance marked **Gate 8** on Calloway Road. This includes Friday, Saturday and Sunday. Competitors are required to self-monitor their temperature prior to entering the competition grounds.
- Volunteers, staff and officials must enter and exit the Park through **Gate 5** on Montrose Road both Saturday and Sunday. Please report to the pavilion for check-in and briefing. You will be greeted by a member of the CHP Covid-19 Safety Compliance Committee who will take and record your body temperature with a touch free thermometer.
- Please remember to practice social distancing of 6 feet at all times while visiting the Park. Do not congregate in groups larger than 25 people and always wear a face mask when within 6 feet of another person including family members, your personal staff, and stablemates. Participants are required to bring their own face masks.
- All **completed packets** will be self-serve and available next to the show office tent and at your stall.
- Hand sanitizer stations are located in every Porto John, on pedestal islands between the barns, at the secretary tent located outside the show office, at the awards table located in the pavilion, at the Show Jumping in gate, and under the white tent outside every warm-up area. Hand wash stations are located next to several of the Porto Johns. CHP will provide hand sanitizer; however, participants are encouraged to bring their own as well.
- Spray bottles of disinfectant are available in every Porto John, under the white tent outside all jump schooling areas, and at the show office tent.
- Please ensure all release forms are signed and turned in to the secretary prior to your arrival
- Equine vendors and food trucks will be available on site. However, there will be no social event on Saturday and no hospitality tent on Sunday. Complimentary bottled water is available.
- The CHP Covid-19 Safety Compliance Committee will be available for questions and monitoring for compliance.
